The purpose of this meeting was to discuss and vote on a proposed increase in the County L.I.T. (Local Income Tax) Tax of .50 percent.

President, Matt Johnson, opened the Public Hearing for the Town of Advance. All other represented Towns, Boone County Council and the City of Lebanon opened Public Hearings as well.

Residents were allowed three minutes to discuss reasons to vote to accept or reject the proposed increase of the County L.I.T.

President Johnson opened the Meeting for the Town of Advance. Councilman Thompson made a motion to accept Resolution number 2016 -06 for the increase in the Local Income Tax of .50 percent for Public Safety. Councilwoman Fry seconded. All in favor, motion passed.

All other Towns, Boone County Council, and the City of Lebanon voted on the increase of .50 percent of the L.I.T. tax.

The tax was passed by all Towns, The City of Lebanon, and the Boone County Council.
