

ORDINANCE NO. 2017- 01

An Ordinance Amending Section 2-1-1 and Section 2-1-2 of the Advance Municipal Code Pertaining to Rates and Charges for Electric Service for Customers of the Advance Municipal Electric Utility of the Town of Advance, Indiana.

WHEREAS, the Town of Advance, Boone County, Indiana (the "Town") previously adopted and codified in the Advance Municipal Code Section 2-1-1 and Section 2-1-2 certain rates and charges for electric service for customers of the Advance Municipal Electric Utility and now wishes to modify the same rates and charges.

NOW, THEREFORE, BE IT ORDAINED, ORDERED, RESOLVED AND ESTABLISHED by the Town Council of the Town of Advance, Boone County, Indiana, as follows:

SECTION 1. Section 2-1-1 of the Advance Municipal Code is hereby amended to read as follows:

Subject to minimum monthly charges as hereinafter stipulated and rate adjustments as provided by Section 3 and Section 4 of this chapter, rates and charges for services rendered by the electric utility of the Town of Advance shall be as follows for each designated class of user:

SECTION 2. Section 2-1-2 of the Advance Municipal Code is hereby amended to read as follows:

For the following described special electric service, the indicated monthly rates shall apply:

When a customer requests street lighting service requiring special poles or fixtures or the use of an underground distribution system, the foregoing schedule of rates shall be increased to cover the Advance Municipal Electric Utility's additional cost to install, own, operate and maintain such special facilities.

SECTION 3. Section 2-1-4 of the Advance Municipal Code is hereby amended to read as follows:

All electric rates shall be subject to quarterly adjustments due to the implementation of the Indiana Municipal Power Agency electric tracker. The tracker is calculated and adjusted according to the cost of power purchased from the Indiana Municipal Power Agency.

SECTION 4. Section 2-1-5 of the Advance Municipal Code is hereby amended to read as follows:

(a) For all electric rate classifications, there shall be charged a flat facility charge as follows:

Residential: \$4.90 per month

Commercial: \$6.00 per month
General Power: \$6.55 per month

(b) The facilities charge shall be in addition to any monthly volume service rates or minimum monthly volume service rates.

SECTION 5. Section 2-1-6 is hereby added to the Advance Municipal Code and shall read as follows:

Should electric service to any customer be disconnected by the Town, either voluntarily or involuntarily, no minimum charges shall accrue on such customer's account during the period services are disconnected. The fee for reconnecting electric service to any customer following a disconnection shall be \$50.00 and shall be due and payable prior to the reconnection being made.

SECTION 6. Section 2-1-7 is hereby added to the Advance Municipal Code and shall read as follows:


Should any customer who is a tenant relocate from one rented residence to another and leave any outstanding and unpaid balance that is due and payable on the electric service account related to the customer's former residence, the Town may disconnect, subject to state law, the electric service related to the customer's new residence until such balance is paid in full.

SECTION 7. This ordinance shall be in full force and effect from and after its passage and approval according to law. This will take effect for February, 2017 use, billed March, 2017.


SECTION 8. This ordinance repeals all ordinances or parts of ordinances in direct conflict therewith.




