#### <u>New After Hours Utility</u> <u>Emergency Phone Proce</u> dure:

We will no longer be using a separate phone for after hours utility emergencies. Simply call the office phone number after hours and you will be automatically redirected to a Town Representative. Please do not call this number for billing questions or concerns. The Representative you are directed to will not have access to your account or billing information.

#### St Rd 75 Project:

Please remember that St Rd 75 is now closed to through traffic during the construction project. Those who do not live directly in the immediate construction area should be using detours accordingly. The Town adopted the County Animal Control Ordinance. Effective countywide 06/01/2019; All pets are required to either have properly registered microchips or have a permanent tag affixed to a durable collar with owner's name, address, and phone number to aid in quick identification and contact of proper owner.

The owner will be responsible for all fines and/or fees if a loose pet is picked up by Animal Control or the Humane Society.
