Boxes – Broken Down	Trash/Garbage
Newspapers/Magazines	Food
Phone Books/Catalogues	Cloth materials
Shredded paper - Bagged(only bagged item)	Chemicals – Paint/anti-freeze/oil
Books – Soft and Hard Covered	Wood/building materials/concrete
Plastic Bottles – ALL kinds - CLEAN	Furniture/Electronics/Appliances
ALL Food Plastic Containers	Fiberglass/Ceramic
ALL Glass Containers - CLEAN	Yard Waste
Plastic Bags/Shrink & Film Wrap/Bubble Wrap	Styrofoam/Polystyrene
Steel & Tin Food/Drink Cans	Light Bulbs

- ALL materials should be placed loosely in the Recycling Bin NO BAGGED MATERIAL ACCEPTED (except shredded paper it must be bagged)
- Do not leave materials outside the bins.
- All bottles, jars, cans & containers need to be rinsed out; labels do not need to be removed.
- Break down ALL boxes
